None of the officials have responded thus far;
Further to our representation of 17 January 2019,
PFA FTL map of Osman Sagor and find the encroachment ORO sports village in the official FTL map, but waiting to be evicted since June 2013 even after official recognition as encroachment.

Eviction of encroachments from the twin drinking water sources, Osman Sagor & Himayat Sagor needs to be done on war footing and drinking water supply to be restored to the Hyderabadis. Hyderabadis yearn for the sweet waters of Gandipet(Osman sagar)

Government of Telangana is giving most perilous and absurd statements in the courts and to the public that 'as drinking water to hyderabad city is brought from 250kms away from river godavari and krishna, we need not preserve the water bodies for drinking water needs of hyderabad'. 2) satellite imagery of 2010, 2011, 2013 and latest that show the gradual landfill and construction of ORO sports village right inside the FTL of Osman Sagor;

Please refer to our below message dated 25 July 2018 addressed to you after meeting Director Technical at your head office, expressing our anguish regarding the fact that Hyderabadis are not supplied drinking water from Osman sagor and Himayat sagor;

Secondly, the encroachments fully acknowledged thru official maps are still not evicted. Enclosed chronological satellite images from 2011 to 2018 overlaid with FTL boundary depicts landfill, compound wall, and ORO sports right inside the drinking water resource of Hyderabad, under your regime.

We expect your prompt action plan on restoration of Osman sagor in terms of its original water spread, in terms of its holding

capacity, and in terms of potable water.

Secondly, action taken on the officials who thru their active commissions and omissions, not conducted office in good faith, and done dereliction of duty and without application of mind, wisdom and ethics, have allowed the ORA sports encroachment.

Dear MD, Do remind all your officials that they are all on the pay-roll of the citizens and residents of Hyderabad; that they are bound to duty and rule of law; taht they are not bound to political leaders, corporators, MLAs, MPs, Ministers.

Await your earliest revert on the matter.

PRESS RELEASE

'REDUNDANT' - AN UNFORGIVABLE EXPRESSION USED FOR OFFICIALLY DESIGNATED DRINKING WATER RESERVOIRS BY GOVERNMENT OF TELANGANA IN THE HIGH COURT at HYDERABAD

Today we, (Sanghamitra, Asif Ali Khan, Lubna Sarwath), met Shri Suryanarayana, Director-Technical, Hyderabad Metro Water & Sewage Board at his office and gave him a representation(attached).

We urged that:

- Water Board take up with government counsel how he stated before high court that two existing drinking water reservoirs can be stated as 'redundant'. we showed him the news item of times of india.

Director said he was not aware of that.

Director also denied any knowledge about Joint Collector RR district filing affidavit in Tribunal regarding illegal layouts/structures/buildings.

we assured him that we would email him the same.

- Water board give us time frame when Hyderabadis can drink sweet waters of Gandipet and Himayat sagar, again, as water board has denied fundamental right of drinking waters supply from twin reservoirs to Hyderabadis.

- Water Board evict all inflow channel blockages and diversions, as Managing Director has himself expressed anguish that despite Excess rainfall in catchment the twin reservoirs failed to be filled up.

- We also reminded him that very recently when Water board asked for release of Nagarjuna sagar waters for the Hyderabad city, the Chief Engineer denied stating that water was needed for irrigation.

Hence, it is simple commonsense and wisdom that we nurture our heritage water reservoirs and not make our city dependent on far off water sources, which are again unpredictable;

These two reservoirs are the shaan(pride) of our city and its pride is essentially in restoring its glory of being able to supply drinking water on a continuum, as it used to be when the inflow channels were not diverted/blocked.

Osman Sagar and Himayat Sagar should not be treated as lakes but as two drinking water reservoirs.

As 'Purification of Land records' process is completed, government immediately examine and tell the court, who are the major land holders in the 84 villages of GO111, and, who are those demanding for shrinking of GO111(as mentioned in HMDA counter affidavit in high court), so that people understand government better when its counsel called the drinking water reservoirs as 'redundant'.

The entire hydrological architecture and structure as bequeathed to the city by VII Nizam Osman Ali Khan through his eminent engineers Sir Mokshagundam Visweswarayya and Mir Ahmed Ali, Nawab Ali Nawaz Jung Bahadur, should be preserved as a heritage marvel in essential utility on a continuum.

It hurts the feeling of possibly loosing these lakes. Unable to hold back my feelings, I put forward my views

1. While there has to be scientific method to prove that Krishna and Godavari water are sufficient all the time to quench the thirst of Hyderabad, there are many drought seasons, when there was no water in Godavari/Krishna. Governments were in tight situation and Water was not released to farmers from Nagarjuna Sagar in order to continue Drinking water supply to city. These lakes could always be used as backup or complementary sources. Probably, if we can think of networking rivers, why not fill these tanks with water from Krishna/Godavari if inflows are blocked?

2 while these lakes served as drinking water resource, the main premise on which this reservoirs were built were to save from floods. City is flooded with water even on account of slightest rain. We can't ignore the flooding affects if these reservoirs are encroached.

3. It defies logic to understand the decision of this TS Govt. On one hand, they claim protecting lakes in Telangana state through Kakatiya Mission and on other hand, they plan to de-notify these two resources. We should go public questioning this contradicting stand.

I strongly feel, we need to convert this issue into movement as none of the the Governments in this country seem to listen unless issues are converted into movement. We have seen this in the past - Corruption, Women Atrocities (Nirbaya's case) issues etc.,

I feel, we need to adopt dual approach - Legal and launch people movement to succeed in our endeavor to save these lakes.

RESOLUTIONS PASSED BY PARTICIPANTS OF ROUNDTABLE CONDUCTED ON 9 FEBRUARY 2017, AT PRESS CLUB, SOMAJIGUDA, HYDERABAD

1- Osman Sagar(Gandipet) & Himayat Sagar should not be denotified as drinking water reservoirs for Hyderabad, hence no question of 'alternate uses'. The present status of Designated Drinking Water Reservoirs should be strengthened by implementation of GO Ms 111, in which protection of entire catchment area is embedded thru endorsement of GO Ms 50 dt 18.1.1989.

Presently Hyderabad receives zero MLD of drinking water from Osman Sagar and Himayat Sagar. City needs the non-energy consuming, gravity enabled sweet drinking waters back, from Osman Sagar and Himayat Sagar.

2- A scientific, economic, environment, and catchment-area study to be undertaken to have free flow of rain waters into the Designated Drinking Water Reservoirs of Himayat sagar and Osman Sagar. All inflow channels of raw water to be opened up, diversions plugged, pollutants stopped at source, and encroachments evicted, on a war-footing, without any compromise or complacence.

3- Government to promptly prosecute all officials mentioned in para 4, 5 and 6 of Memo No. 14046/11/2007 dated 12 October 2007, as officials responsible to 'not to allow any construction, layout and non-agriculture

development activity within the upstream area of Himayat Sagar and Osman Sagar lakes in tune with GO Ms 111 MA dt. 8.3.1996.

4- Rehabilitate deserving violators by identification under set criteria as government's responsibility.

5- As per GO MS 111 dt 8.3.1996, 3(iii), 'Orders issued in Go Ms 50 dt. 18.1.1989 shall be effectively implemented by concerned departments i.e., 1- zilla parishad ranga reddy, mahbubnagar and medak districts. 2- Panchayat raj department 3- irrigation department 4- social welfare department are directed not to take up any building works/check dams/ lift irrigation works/ storage reservoirs across vagus flowing in the catchment areas'.

6- People must be taken into confidence. Government and Committees formed by government must abide by law and cannot take law as discretion.
